### **NEW BUSINESS**

A. A Resolution of the La Junta City Council Authorizing the La Junta Historic Preservation Board to Act as a Reviewing Entity for the State Income Tax Credit Program for Qualifying Rehabilitation Projects C.R.S. §39-22-514.5, As Amended. Resolution No. R-13-2018 for Council's consideration as follows:

WHEREAS, the La Junta City Council and the City of La Junta Historic Preservation Board support the creation of incentives to assist in the preservation and protection of historically significant resources; and

WHEREAS, Colorado House Bill 14-1311 (C.R.S. § 39-22-514.5, as amended) was signed into law May 14, 2014, establishing tax credits for historic structures throughout the state; and

WHEREAS, La Junta, as a Certified Local Government, pursuant to the provisions of 54 U.S.C. § 3025, as amended, is eligible to review such rehabilitation tax credit projects as a reviewing entity as defined by C.R.S. § 39-22-514.5 (5.5) (c); and

WHEREAS, the provisions of C.R.S. § 39-22-514.5 (5.5) (c) require that each Certified Local Government adopt a resolution stating whether such Certified Local Government will act as a reviewing entity; and

WHEREAS, the La Junta Historic Preservation Board, as the City of La Junta's official agency for the identification and protection of historic resources, endorses rehabilitation project reviews at the local level, providing an increased level of preservation service to our community.

# THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF LA JUNTA, COLORADO:

Section 1. The City of La Junta through the La Junta Historic Preservation Board, hereby agrees to act as a reviewing entity for the purposes C.R.S. § 39-22-514.5 and agrees to adhere to rules and requirements that may be promulgated as outlined in C.R.S. § 39-22-514.5 (5.5) (c).

### B. A Resolution of the La Junta City Council Concerning the Designation of a Historic Site. Resolution No. R-14-2018 for Council's consideration as follows:

WHEREAS, the La Junta City Council and the City of La Junta Historic Preservation Board support the preservation and protection of historically significant resources; and

WHEREAS, Colorado House Bill 14-1311 (C.R.S.  $\S$  39-22-514.5, as amended) was signed into law May 14, 2014, establishing tax credits for historic structures throughout the state; and

WHEREAS, La Junta, as a Certified Local Government, pursuant to the provisions of 54 U.S.C. § 3025, as amended, is eligible to review such rehabilitation tax credit projects as a reviewing entity as defined by C.R.S. § 39-22-514.5 (5.5) (c); and

WHEREAS, the provisions of C.R.S. § 39-22-514.5 (5.5) (c) require that each Certified Local Government adopt a resolution stating declaring sites as historic and thus eligible for rehabilitation and tax credits; and

## THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF LA JUNTA, COLORADO:

The City of La Junta hereby declares Hanger 103, located at the City Industrial Park at 30273 First Avenue, La Junta, Colorado, to be a historic site as defined in the statutory provisions set forth above with a period significance from 1942 to 1996 and designation under Criteria A for its character, interest or value as part development, heritage or cultural characteristics of City, County of Otero, State of Colorado, or the United States of America; and Criteria F for its embodiment of distinguishing characteristics of our architectural type or specimen.

MOTION TO ADOPT RESOLUTION NO. R-14-2018: Lovato

SECOND: Mestas

DISCUSSION: There was no discussion affecting the vote

VOTE: The motion carried 6-0 (Eckhart absent)

C. Request from The State Bank expressing interest in purchasing vacant land made available after demolition of the Kit Carson Hotel. Mr. Klein explained that this is not the first time State Bank has shown interest in this lot. It's the discretion of the Board as to which direction we go. If we decided to go forward with this, we would have to put it out to bid. After conversation by the Board, it was decided to move forward at this time. The City Council directed City Manager Klein to move forward with an RFP.
